

Terms And Conditions

The terms and conditions described here form a legally binding agreement between the user of the game and the provider that is Real Money Quiz. Every user of the Real Money Quiz must read, agree, and abide by these terms and conditions throughout the use of the platform. Please read every element of the terms and conditions carefully before registering for or using the services provided by Real Money Quiz.

General

- 1) Any person (hereafter referred to as the user) accessing RealMoneyQuiz.com website or Real Money Quiz mobile application (hereafter referred to as App) including any sub-domains or related top-level domains, mobile sites, APIs, widgets (hereafter collectively referred to as Real Money Quiz platform) or information, graphics, pictures, text or any material posted, sent, uploaded, communicated, or otherwise publicized through the platform (hereafter collectively referred to as content) for participating in the available games, quizzes, and contests on the Real Money Quiz platform will be bound to obey these Terms and Conditions for use of the platform and services provided by Real Money Quiz.
- 2) By registering to the platform, you agree and acknowledge that you have read and completely understood the rules and regulations stated in the terms and conditions as well as privacy policy.
- 3) We have complete legal ownership and reserved rights for amending or supplementing the terms and conditions from time to time if required, to regulate the access and use of our platform and content; without any prior notification of the change to the users. The changes will be effective from the time they are posted on the platform. All the users may then be notified as to the sole discretion of Real Money Quiz about the changes via email to their registered IDs. In case, the users fail to exercise a response for non-agreement within the given time-frame, the users will be considered to have accepted the amended terms and conditions.
- 4) Participation in the seasonal contests or use of specific content such as classified features, functionality, programs, promotional feeds, and wireless marketing content are subject to additional terms and conditions. Users must ensure to read, understand, and comply by these rules as published and revised by Real Money Quiz.
- 5) We reserve the discrete rights to:
 - a) Terminate the access of a user without any prior notification.
 - b) Change or remove any content that is available through the platform.
 - c) Establish general practices concerning the use of the platform.

Services Provided by Real Money Quiz

- 1) Real Money Quiz, in compliance with the mentioned terms and conditions, grants a non-exclusive, royalty-free, revocable, limited access to the users of the platform as part of the offered services. The granted access enables users to play games and quizzes as available through the platform from time to time, according to the terms.
- 2) You as a user, are granted a limited, non-transferable license to view and access the content for personal or non-commercial purposes only.
- 3) Our services may include advertisements targeting specific content or information. The type and extent of advertisements are subject to change by Real Money Quiz.
- 4) Every game or quiz provided by the platform includes certain rules for scoring, control, and guidelines to play the game. Such rules are integral to and inclusive of the terms and conditions, which the user must agree and comply with.

User Registration and Platform Access

- 1) Every user must register to the platform to gain complete access to the services offered by the platform. A user without a registered account is not authorized to access any services of the platform.
- 2) In order to register with the platform, users need to create an account by providing certain details as per instructions.
- 3) Users must be adults above the age of 18 and residents of India to access or use our platform. We reserve all the rights to request any proof confirming the age of the user to verify their credibility.
- 4) Users are requested to provide accurate, current, and complete information true to their knowledge during registration to avoid future discrepancies.
- 5) Registered users are permitted to use the services of the platform and participate in contests.
- 6) You should not allow other users to access your account or use theirs to access our platform. If Real Money Quiz identifies a user accessing the platform through multiple accounts, we reserve the right to restrict user access or ban such accounts.
- 7) We at Real Money Quiz offer individual live trivia games or quizzes which will be announced to the registered users from time to time. The users may join the contests when they are live. The users will be informed beforehand about the contest duration and other necessary details related to a contest. The users may need to pay a nominal participation fee to enroll for a contest.
- 8) The user agrees to be responsible for ensuring the confidentiality of the registered account and shall be solely and fully responsible for any or all the activities occurring by the use of that account.

The user is solely responsible for the security of the transactions undertaken through his/her account. We cannot be held responsible for any inconvenience or financial loss caused by misuse of the user account.

- 9) Every user must agree and undertake to immediately notify us of any unauthorized use or malicious activity generated through his/her account. Real Money Quiz will not be responsible for any loss or damage, direct or indirect, arising out of the user's failure to inform or comply with the requirements of use.
- 10) To use our services, the user agrees to:
 - a) Download and open our App on his/her device
 - b) Register and sign up for an account or log in to an existing account. The users need to register for participating in the contests and quizzes
 - c) Play the quiz while it is live
 - d) Receive notifications on his/her device for the commencement, conduct, and termination of the quiz
 - e) Answer each question in 10 seconds
 - f) Provide accurate, valid, and complete information about self
 - g) Promptly update and maintain the registered information to keep it accurate, current, valid, and complete.
- 11) The user accepts that a contest may be considered void in case of non-fulfillment of the requirements.
- 12) We hold no responsibility for the non-fulfillment of the awarded amount to a user by any third-party payment service provider.
- 13) The user also hereby accepts that Real Money Quiz reserves the sole right to disqualify or terminate any entry which is not in good faith, seems to be generated by an automated script, or violates any of the terms and conditions of usage of the platform.

Security and User Conduct

- 1) Access to a user account for adding, deleting, and modifying any data is password protected. Users are advised to keep their password safe and secure to avoid a security breach. Users agree not to disclose their password to anyone and shall not allow any other person to use or access their account, in any case. Real Money Quiz is neither responsible if another user accesses or uses your account nor in case of any activity concerning your account.
- 2) Users of the platform are obliged to protect the information and content provided through our platform including, but not restricted to, usernames, passwords, contact information, bank account details, etc. Real Money Quiz does not incur a liability for exposure or misuse of the information provided by you via any other person.

- 3) Users should routinely check their account balance section to ensure no unauthorized access has been made to the account. Again, users must immediately change their password and report our support team in case they suspect unauthorized access or malicious activity.
- 4) We reserve the right to decline or revoke application to a user's account at any stage at our sole and absolute discretion without any prior notice or assigning any reason.
- 5) To access the Real Money Quiz platform, you agree not to:
 - a) Use automated devices or scripts to access, retrieve, or index our platform or content without prior consent
 - b) Use any device or platform to interfere with proper working of Real Money Quiz platform
 - c) Use or index the content and data of our platform to compete with us
 - d) Use the content and services of our platform for a different non-reasonable purpose whether commercial or non-commercial
 - e) Violate user rights, copyrights, privacy policy, proprietary rights or use of intellectual property
 - f) Pose as a person or entity to solicit money or confidential user information
 - g) Violate any statement in the terms and conditions of use
 - h) Republish, modify, reproduce, retransmit, distribute, translate, recreate, copy, sell, trade, or exploit our platform, content, and services
 - i) Attempt to transmit a computer virus, worms, Trojan horse, or any other destructive content
- 6) In the event any of your activities violate our terms and conditions, we have reasonable rights to initiate appropriate legal actions against you and notify the relevant law enforcement and regulatory authorities wherever appropriate along with executing other available remedies under equity and law. We can, under such circumstances, restrict, suspend, or terminate your use of the Real Money Quiz Platform.

Contest and Prize Distribution

- 1) Real Money Quiz provides live multiplayer online quiz games where participants can pick a tournament of their choice.
- 2) All our quiz games are trivia games wherein prizes are distributed among participants. Each contest will have a fixed number of participants who can join the contest by providing a minimal entry fee. All the participants must be 18+ years. The total amount accumulated for a contest will be distributed among the winners based on their ranking.
- 3) The winner percentage and prize distribution will be predetermined. Also, the time of the contest is fixed.

- 4) Contest details will be provided prior to the commencement of a quiz contest.
- 5) Users can add money into their registered accounts via multiple payment options such as debit/credit cards, net banking, Paytm, or Google pay.
- 6) When applicable, the winners who receive a Prize may be required to:
 - a) Furnish proofs for identity, birth date, and residential address
 - b) Furnish a copy of the pan card along with necessary details
 - c) Compulsorily link a valid account or Paytm account required to use specified third-party payment service providers for receiving the winning amount
- 7) Real Money Quiz shall initiate the payment of a Prize to the winner at its sole discretion, at a time and date solely decided by us via Paytm or any other third-party payment service provider. The Cash-Out is also subject to the terms and conditions of use as well as the Privacy Policies of Paytm or any other third-party payment channel. We hold the right to forfeit the Cash-Out amount in case the Prize is not claimed by the winner within the notified period from the announcement of the winning amount.
- 8) Real Money Quiz contests shall be conducted under our supervision. The decisions made by us relating to the contests and prizes are final and binding. The winners of the contest will be notified either by SMS, email or via the App. We reserve the right to use an alternate method of notification.
- 9) The winning amount is not transferable. We reserve the right to not award a prize in case a winner cannot claim the reward in due time for any reason or prize cannot be granted due to Applicable Laws.
- 10) The user must acknowledge the fact that certain jurisdiction may have laws regarding quiz contests that may prevent Real Money Quiz from awarding a prize to the winners. By participating in a contest, the user accepts and understands the risk that he/she may win but may not be able to claim or receive a prize.
- 11) The contests can be categorized into two types:
 - a) Premier Quiz games consist of multiple rounds with fixed number of questions in each. Every question in each round will have four options. Participants have to select the correct one within 10 seconds to gain points. The earlier a participant answers, the higher it moves up the rank. A wrong answer eliminates the participant from the contest. A ledger board will be released after each round to help participants track their ranks. Final rank will be revealed after round three.
 - b) 24/7 Quiz games consist of a single round with a fixed number of questions. Rest of the rules remain the same for this game type.

- 12) Participants will be ranked on the basis of total time taken in all the three rounds combined and prizes will be distributed accordingly. Users can withdraw/transfer the winning amount to their verified bank accounts/ wallets after proper account verification.
- 13) Prizes will be distributed equally among winning participants in case of a tie.
- 14) Real Money Quiz makes no representation or warranties to the quality, merchantability, or suitability of any prize money and shall not be liable in respect of the same to the extent permitted by law.
- 15) We have the right to vary, modify, or change the prizes being offered to the winners at our sole and absolute discretion. Participants shall not raise any claim against Real Money Quiz or question its right to modify the prizes being offered, prior to closure of a contest.
- 16) We bear no responsibility for the transportation or packaging of the prizes to the respective winners. Real Money Quiz shall not be held liable for any loss or damage caused to the prizes at the time of transportation.
- 17) The Winners shall bear the shipping, courier or any other delivery cost as well as the transaction charges, if any, levied for the delivery of the cash prizes. All prizes are non-transferable and non-refundable. Winners cannot exchange or redeem the prizes for cash or kind. No cash claims can be made in lieu of prizes in any kind.

Taxes

- 1) All the cash prizes will be subject to deduction of tax as per the Income Tax Act 1961. The winners shall be liable and responsible to pay all the taxes applicable on any prize money.
- 2) Taxes will be deducted by Real Money Quiz in accordance with the current prescribed TDS rates. The winners agree and acknowledge that the company may deduct the taxable amount from his/her account of requested by a tax authority, required by law in pursuit of an agreement with the tax authority, or to comply with the internal company policies, applicable order, or sanction of any tax authority. Winners will be notified and provided TDS certificates pertaining to such tax deductions.
- 3) The winners will be responsible for the payment of other applicable taxes, including but not limited to, gift tax, service tax, income tax, etc. related directly or indirectly to the prize money.

Platform Usage Restrictions

- 1) Real Money Quiz may not allow individuals living in the states of Assam, Odisha, Telangana, Nagaland and Sikkim to participate in the games, in accordance with the laws applicable in these Indian states that bar any person resident in the area from participating in paid games of skill where the users are required to register and pay certain fee to enter a contest.

- 2) You as a user agree and acknowledge the permission to monitor and use certain technologies for monitoring activities such as logging of your IP address for verifying and confirming your geographical location. We may request your bank details as an address proof as a final check during KYC approval.
- 3) We do not permit the users who are residents of the aforesaid Indian states to access our platform and create an account. Users of our platform agree and acknowledge that in case a resident of these Indian states try to become a user by providing false information, he/she bears the sole liability and Real Money Quiz reserves the right to terminate, delete, or remove such account with falsified information without any prior notice. Such users shall not have the permission or right to redeem or demand any balance amount from the user account.
- 4) Real Money Quiz will not be liable or held responsible in case of a breach of applicable usage as per state laws by a user. The respective state and central government of India are free to impose appropriate penalties on such users as the case maybe.
- 5) Being a user of Rela Money Quiz, you have to ensure that you comply with the applicable state laws. We try our best to post any changes if found appropriate to inform and better educate our users. You acknowledge and agree that our decision will be final and binding in this regard and no consideration will be extended to any user.

- 3) When you play a sponsored Quiz, you agree and acknowledge the fact that any information you provide in connection with the Quiz can be used by the Sponsor according to their terms of use.
- 4) In no event shall Real Money Quiz be liable for any direct, indirect, special, incidental, punitive, consequential or any other damages caused by:

- a) The improper use or inability to use the offered services
 - b) Unauthorized access or alteration of the user data
 - c) Any matter related to availing the services including damages for loss of data, usage, or profits
- 5) Real Money Quiz shall not be responsible for non-availability of the platform and website during periodic maintenance or an unplanned suspension of access that may occur because of technical or any other reasons whatsoever. The users must understand and agree that any content downloaded or obtained through the platform will be at their discretion and risk. Users will be solely responsible in such cases if any damage is caused to their equipment or any other material loss resulting from such data.
- 6) These rules and regulations including exclusions, limitations, and the disclaimer of warranties apply irrespective of whether the damage is caused by:
- a) Breach of contract

 - c) Negligence
 - d) Any other user action

Unless prohibited by the applicable laws.

Termination

- 2) In case of termination of this agreement, the users must immediately discontinue the use or access to the platform and destroy any information or data obtained through the platform. The user agrees and understands that we may immediately terminate the user account and platform access without prior notice. Causes of termination may include, but not limited to, request by user, breach by the user of any of the terms of usage, or request by enforcement, law, or government agencies.
- 3) Upon termination of this agreement, the user's right to access and use the platform shall immediately cease. The user shall have no obligation or right to execute any uncompleted tasks. Once the services are terminated, suspended, or cancelled, users may not be able to retrieve any data stored on the platform.
